Building Readiness

- All common areas will be regularly disinfected and cleaned throughout the day.
- Hand sanitizer stations will be available in multiple locations throughout the building.
- Elevator maximum occupancy has been increased from two to four employees.
- Areas that are OPEN during Phase 1
 - Fitness Center
 - Main Kitchen – Bruce’s Bistro
 - Kitchenette’s
- Conference Rooms
 - You are **no longer required** to complete the Essential Business Meeting Request form.
 - Room capacity will be **limited** and is noted when reserving a conference room. When scheduling a meeting in Outlook, please ensure the invitee list does not exceed the limit indicated.
- Office meetings are permitted with no limitations

Garage Parking

- During Phase One, most parking spots will be on a first come, first serve basis.
- Spots that are reserved for Executives will be indicated with a red marking.

NOTE: We **DO NOT** have charging stations for Electric Vehicles. Employees are asked to ensure their vehicles are charged prior to arriving at work.
