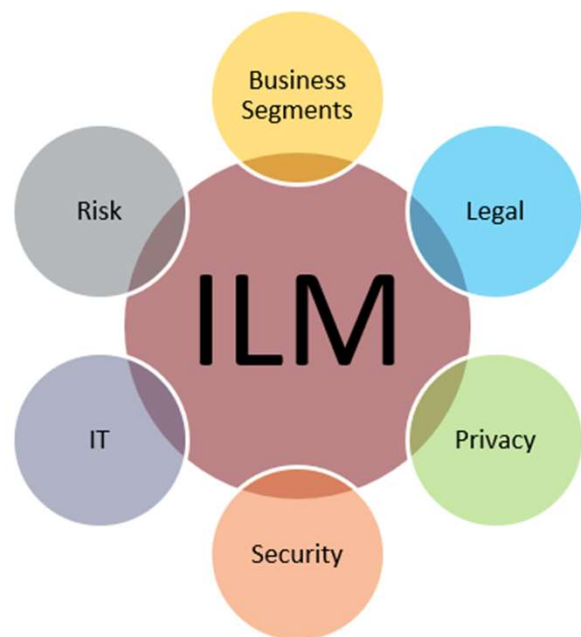

## Litigation

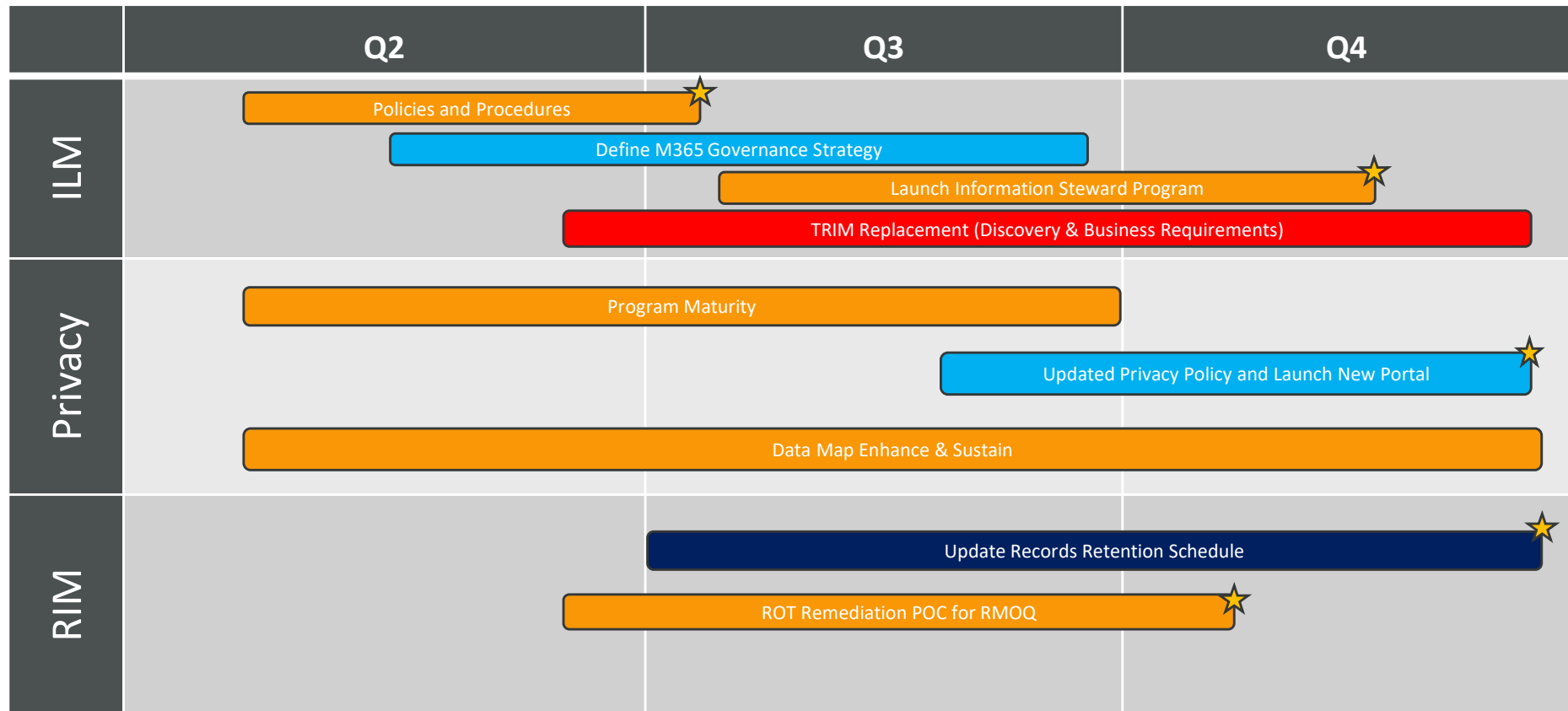
- Leverage eDiscovery tools to execute Legacy Data Remediation
