





OUR CULTURE

Clear Roles and Expectations

First Monday of the month - Open the CTA and the Safety & Quality Focus and read through it. Share the CTA with your manager and your team.

Complete the CTA Acknowledgement survey. Within the first few days, meet with your AOR's to **delegate** out their action items and set the expectation. The AOR's are listed at the top of each page to make this easy for you to do.

Remember, you are a Safety "Leader". Lead your AOR's to help them complete their action items. This ensures everyone at your store gets involved.

Use the morning huddle - This is a great, easy way to discuss CTA topics and observation results as a team and solicit feedback. Watch the SQF video as a team and discuss. Finally, complete your survey and feedback.

First Monday of the Month

- Open monthly CTA and SQF and review material
- Share CTA with leadership team (Mgr., Sr., etc.)
- Complete CTA Acknowledgement

First Week of the Month

- Within the next few days, meet with your AOR's to delegate out their action items and set the expectation


