



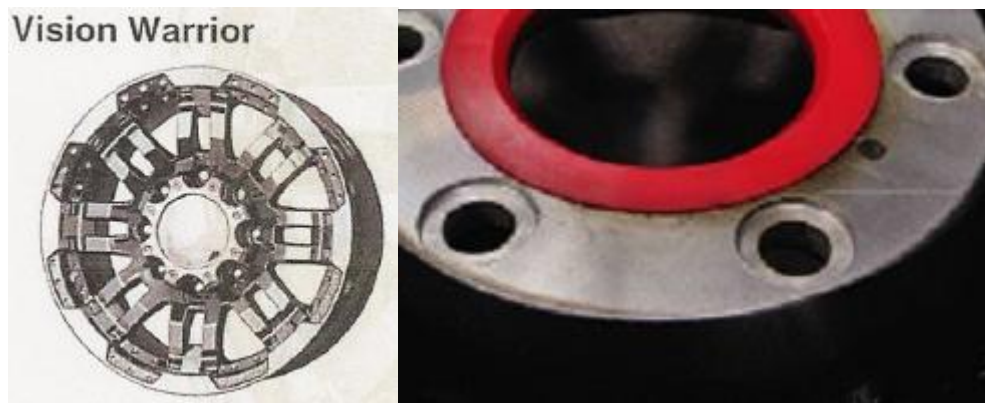
**IMPORTANT SAFETY  
RECALL NOTICE-  
NHTSA Recall 12E-022**

Re: Your purchase of Vision Wheel "Warrior" style

Dear

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Vision Wheel has decided that a defect which relates to motor vehicle safety exists in certain wheels manufactured by Vision Wheel, model "Warrior in Phantom Black finish", select 17" & 18" sizes (see picture below). Specifically, the defect is the insufficient machining of the hub bore for use of a hub centering ring, which could potentially result in incorrect wheel mounting when the wheel is used with a hub ring. Our records indicate you purchased one or more of these wheels from a Discount Tire/America's Tire store.



The insufficient machining and use of the supplied hub centering ring for these wheels may cause the wheel and tire assembly to become loose or potentially fall off during vehicle operation. This is hard to predict and depends on a variety of circumstances, but could lead to a loss of control and a vehicle crash. Because Vision Wheel and Discount Tire/America's Tire care about your safety and satisfaction, we strongly encourage you to call as soon as possible for an appointment for a free inspection of your wheels, and a free replacement of your wheels if they are found to contain the defect, in order to prevent this potential problem. We expect that the inspection and (if necessary) replacement will take approximately one hour. Please call the store from which you bought the wheels or the Discount Tire/America's Tire toll-free hotline at 800-385-3322. Vision Wheel and Discount Tire/America's Tire believe it is important to resolve this situation as a sign of our appreciation upon completion of your inspection, you may use this letter as a free \$100 gift certificate towards the purchase of any Discount Tire/America's Tire product.
