Flat repair, TPMS, tire rotation**Flat repair:**

We follow U.S. Tire Manufacturers Association guidelines

- Use "FLAT" as a purchase order number for no charge flat repairs.
- Flat repairs will be patch-plugged internally and balanced.

TPMS:

- Use "TPMS" as a purchase order number for no charge TPMS resets.

Tire rotation:

- Use "ROTO" as a purchase order number for no charge tire rotations.

Tires**Replacement:**

- Replace tires when tread is down to wear bars for all tires on all vehicles unless otherwise directed by Comcast Fleet Team. Between Oct. 31st- March 31st, all tires for all vehicle types are to be replaced when tread is 4/32nd or less.
 - Have measurements ready when calling for authorization
 - Must document location of tire(s) being replaced
- Replacement tires must meet or exceed the following criteria:
- Manufacturer recommended size, speed rating, and load range.
 - Choose the most cost-effective option to match Comcast National Account pricing as closely as possible. Reference Comcast Fleet for pricing.
 - No used tires are to be installed. Vehicle's full-sized spare tire should be utilized if possible.
 - Certificates are NOT to be sold.

Damage versus Normal Wear & Tear:

- Pictures are required when there is damage to tires/rims.
- If an alignment is required post repair, contact that information to the Comcast Fleet Team.
- Contact the Comcast Fleet Team for additional instructions on what needs to be photographed, and where to send pictures.
