

Policy and Procedure

Manufacturer Employee Rebate Program

Policy

ALL full and part-time employees and their spouses are eligible (unless noted by the manufacturer).

Excludes Store Manager charges.

The following applies:

- The employee or their spouse **MUST** have financial ownership of the vehicle.
- Rebates **MUST** be filed within **four months** after the date of purchase.

IMPORTANT:

- Store Manager must approve excessive trade-in allowances by signing the invoice and noting the trade-in is acceptable before submitting the rebate request.
- It is preferred that purchases of tires be in sets of four.
- Invoices with unusual circumstances will be forwarded to a Senior Vice President for approval before rebate processing.

Rebate Calculation

Supplier rebates are calculated by the Accounts Payable Department and are refunded to the employee through Payroll. Sales invoices should reflect the "employee" cost.

Procedure

To request a rebate:

Step	Employee
1	Verify that your purchase meets the rebate criteria shown in the table above.
2	Fill out one Employee Rebate Request Form for each article number. Note: After submitting, Accounts Payable Department may need to confirm information. You will be asked to provide one or all of the following: <ul style="list-style-type: none"> • Purchase invoice • Copy of current vehicle registration • Owner verification form
